The Security & Safety Supervisor is responsible for supervising venue security and event security operations for Paper Mill Playhouse. You will lead efforts to maintain a safe environment, enforce safety protocols, and ensure smooth security operations for both everyday activities and events.

Essential Functions

- Safety & Security Enforcement: Ensure the safety of all staff, patrons, and physical assets of Paper Mill Playhouse, its public areas, Paper Mill Studio and the F.M. Kirby Carriage House Restaurant and Bar.
- Scheduling: Assist Security & Safety Manager with the scheduling of Staff, Parking, Shuttle and Police coverage.
- Ability to assist Security & Safety Manager with assessing, developing, and implementing security plans and procedures.
- Incident Response: Respond promptly and professionally to safety and security calls.
- Stage Door Administration: Manage pre-entry screening and protocols, oversee CCTV surveillance, building access, and fire command systems.
- Mail & Package Handling: Assist with receiving and distributing staff mail/packages and overseeing outgoing business mail.
- Customer Service: Maintain and enforce high customer service standards in compliance with Paper Mill Playhouse protocols.
- Adaptability: Quickly adjust to changing situations without losing efficiency or composure.
- Communication: Foster strong relationships with local authorities, including Millburn Police and Fire Departments.
- High Visibility: Serve as a visible deterrent to theft and property damage through high visibility and patrols.
- Crowd Control: Assist with crowd management during events to ensure orderly entry and exit through a weapons detection system.
- Performs other duties as assigned.

- AED and CPR certification (60 days provided to obtain).
- Proven ability to work under pressure, with excellent verbal and written communication skills.
- Experience interacting with various stakeholders, including external partners, patrons, and employees at all levels.
- Strong attention to detail and organizational skills, with the ability to manage multiple priorities.
- Familiarity with security hardware/software.
- Willingness to work flexible hours, including evenings, weekends and holidays.
- Knowledge of CCTV, surveillance equipment, radio communications systems, life safety, and fire codes.
