Tuition Assistance Request deadline: March 21, 2025

All Tuition Assistance Requests must include:

- 1) Completed application with Statement of Need (pg. 2)
- 2) Copy of parents' 2024 Federal Tax Form 1040 OR Copy of parents' 2023 return with a description in your Statement of Need of how your financial circumstances may have changed since 2023
- 3) Copy of parents' most recent pay stub

- PLEASE NOTE -

A copy of parents' federal income tax return must be included for consideration of any Tuition Assistance request. Please note that this Tuition Assistance Request is due PRIOR to the US Federal tax deadline. The applicant may submit their family's 2024 tax returns if they are prepared by our deadline. If the 2024 returns are not prepared by the application deadline, the applicant may submit their 2023 returns accompanied by a description in the *Statement of Need* (page 2) of how the family's financial circumstances may have changed since 2023. Tax returns for 2024 should be forwarded to our office as soon as they are prepared. If you have concerns about this requirement, please contact our office.
